- The terms “placement” and “placement practitioner”.

The remainder of the visitors’ report (including the conditions and recommendations in the report ) should be accepted.

**Reasons**

The Panel is satisfied that the condition against SET 2.1 went beyond the requirement of the standard. The reference to Academic Quality removed as the position did not exist.

The Panel is satisfied that the remainder of conditions in the Visitors’ report must be met before the programme can be approved or before the ongoing approval of the programme can be confirmed and that the Executive should contact the Education provider to provide further clarity.
